PROGRAMME OUTLINE

Ethics and Integrity in Financial Services

- Explore the key principles of ethical behaviour in financial services.

Introduction - Saving and Borrowing

- Define key financial services terms and principles including savers, borrowers, equity, bonds, risk and reward, insurance and foreign exchange.

Banking

- Identify the difference between retail and commercial banking.
- Explains the functions of each banking type and their customers – individuals or corporates.
- Explain loans, mortgages and overdrafts, credit cards, interest rates and how they are calculated.

Equities / Shares / Stocks

- Explore the reasons for issuing shares to finance a company and the return that can be gained – dividend/ capital gain.
- Provide an understanding of shares, what they are for, and the risks involved in owning them.

Bonds

- Identify the two main issuers of bonds – companies and governments.
- Covers the features of bonds as well as the advantages and disadvantages of investing in bonds.

Markets

- Explain how a stock exchange operates and the purpose of a stock exchange index.
- Compare different stock markets around the world.

Other areas of Financial Services

- Highlights other key areas including Fund Management, Foreign Exchange, Insurance and Retirement Planning.
