At CSPS and upon retirement, she facilitated and continues to facilitate several training workshops in the areas of Strategic Foresight, Strategic Planning, Industrial Revolution 4.0 (IR4.0), Change Management, Geographic Information Systems, Presentation Skills and Report Writing for the government and the private sector. At UBD, she teaches Strategic Foresight & Planning on the Master of Government programme. In recent years, Sophiana focuses on assisting the government and private sector organisations in applying Strategic Thinking, Foresight and Systems Thinking in the development, alignment and monitoring of strategic plans.

Sophiana holds a Bachelor of Science Honours in Computer Science from Swansea University, a Master in Computer Studies (AI) from Essex University and a PhD in Computer Science from Kent University, The United Kingdom.
