Ms. Sufinah is the Chief Executive Officer of Brunei Institute of Leadership and Islamic Finance (BILIF), the Centre of Excellence for the finance industry under the purview of Brunei Darussalam Central Bank (BDCB).

Ms. Sufinah began work in BILIF as Acting Chief Executive Officer in 2018. Under her leadership, BILIF has been busy in a few fronts, most notably with the development and implementation of the Continuous Professional Development (CPD) for the financial industry and the introduction of the Leadership in Islamic Finance and Economics (LIFE), a multi-tiered qualification programme that is designed to develop and groom aspiring professionals to become Islamic Finance experts. BILIF has also started offering its first line-up of tertiary qualifications in collaboration with The London Institute of Banking and Finance (LIBF). Through these and many other achievements, BILIF has received multiple awards and accolades, including the GIFA Excellence Award (Islamic Finance Training and Education) in 2019, 2021 and 2022 at the Global Islamic Finance Awards (GIFA) and the award for Best Islamic Finance Education & Training Brunei 2021 by the Global Banking & Finance Review® among others.

Concurrent to her former Acting CEO role at BILIF, Ms. Sufinah was also the Assistant Managing Director of Corporate Development Department at BDCB. Her stint at BDCB began as Executive Director and Head of Corporate Services Unit in 2011, on the 5th month of BDCB's first year of establishment, mainly to lead the Accounts and Finance, Administration and Information Technology. She was also previously the Assistant Managing Director at Darussalam Holdings Sdn Bhd. Her expertise ranges from financial management, project management, facilities management human resource management as well as transformational change management.

Ms. Sufinah has a Bachelor of Degree in Accounting and Financial Management from University of Sheffield. She is a Fellow Member of Association of Chartered Certified Accountants (ACCA).

YAACOB BIN IBRAHIM

Dr Yaacob Ibrahim graduated from the University of Singapore with a Bachelor of Engineering degree in Civil Engineering (Honours) (1980), and a Master of Science in Civil Engineering (1984). He worked as a structural engineer before proceeding to pursue a PhD at Stanford University in 1984.

In 1990, after a stint at Cornell University as a post-doctoral fellow, he returned to Singapore and joined NUS. He served in the Department of Industrial and Systems Engineering as an Associate Professor until 1998. During his time at NUS, he received a departmental Teaching Excellence Award and in 1997, co-founded the Centre for Robust Design, which undertook research into reliability issues relating to products and processes of industries in Singapore.

Dr Yaacob bin Ibrahim, is a former Singaporean politician. A member of the governing People's Action Party, he is previously Minister for Communications and Information, Minister-in-charge of Muslim Affairs and Minister in charge of Cyber Security.

Ben Cashore specialises in global and multi-level environmental governance, comparative public policy and administration, and transnational business regulation/corporate social responsibility. His substantive research interests include climate policy, biodiversity conservation/land use change, and sustainable environmental management of forests and related agricultural sectors. His geographic focus includes Southeast Asia, North America, Latin America and Europe.

Ben's theoretical interests include the legitimacy and authority requirements of non-state market driven (NSMD) global governance, the influence of economic globalisation on domestic environmental policies, and the potential of anticipatory policy design for identifying path dependent policy mixes capable of ameliorating "super wicked" environmental problems. He integrates his theoretical and empirical research around two key themes:

1. Developing and managing problem oriented multi-stakeholder policy learning processes; and
2. Strategies for nurturing multiple step policy pathways.

Ben joined LKYSPP after spending 18 years at Yale University as a professor of environmental governance and political science, where he also directed the Governance, Environment and Markets (GEM) initiative and, from 2014-2019, directed the Yale International Fox Fellows exchange program which awards promising graduate students in 18 partner universities. Ben was born and raised in British Columbia, Canada. His PhD is from the University of Toronto and he undertook postdoctoral research at Harvard University and the University of British Columbia. He worked for three years in Ottawa, Canada as a policy advisor to the leader of the Canadian New Democratic Party.

Rajaratnam School of International Studies, Nanyang Technological University.

Chin Chong has worked with JTC Corporation, a Singapore Statutory Board, and several real estate developers. He was also the master planning consultant for several large-scale industrial parks of China, Malaysia and Indonesia.

As the Executive Vice President of Singbridge International Pte Ltd, Chin Chong was responsible for coordinating physical development projects. He took charge of various development teams to align the design, planning and execution to meet the strategic and business objectives, and worked with various divisions to explore, evaluate, secure and implement new developments.

Prior to his Singbridge's appointment, Chin Chong was the Deputy Managing Director of the Property Development Division of Sembawang Engineers and Constructors Pte Ltd. He was in charge of planning, design, development and management of properties.

From 2008 till 2011, Chin Chong was a pioneer of the Sino-Singapore Tianjin Eco-city project. He was Deputy Chief Executive Officer of Sino-Singapore Tianjin Eco-city Investment and Development Co., Ltd in charge of planning and development of the 30-sq km eco-city. He was also involved in site selection, research, strategic planning of this eco-city. Within his 3-year stint, he initiated and developed two industrial parks and eight residential estates.
