# OVERVIEW

An Excel Dashboard is a page that allows managers and business leaders to effectively track key Key Performance Indicators (KPIs) and make well-informed decisions. It incorporates diagrams, tables, and views that are substantiated by accurate data. However, it's important to note that not all reports qualify as dashboards. Dashboard reports provide administrators with a high-level summary of their company's performance.

Excel proves to be an exceptional tool for crafting robust dashboards, enabling managers to assess, scrutinise, and receive timely alerts. In this intermediate-level programme, the primary objective is to construct an interactive report using specialised functions and naming conventions. Participants have the flexibility to customise report requirements using form elements such as option buttons, drop-down lists, and buttons. This approach ensures a more engaging and user-friendly reporting experience.

# OBJECTIVES

- Implement formatting to present data in a clear and easily interpretable manner for the management.
- Utilise functions that transform the report into an interactive format.
- Create the Dashboard interface by leveraging Microsoft Excel's Form Elements, all without the need for any programming expertise.

# WHO SHOULD ATTEND?

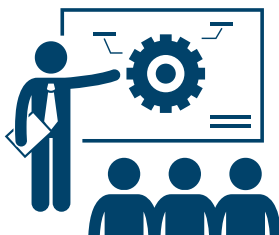
Any personnel that uses Microsoft Excel to analyse and prepare management reports, especially administrative, operational and middle management staff.

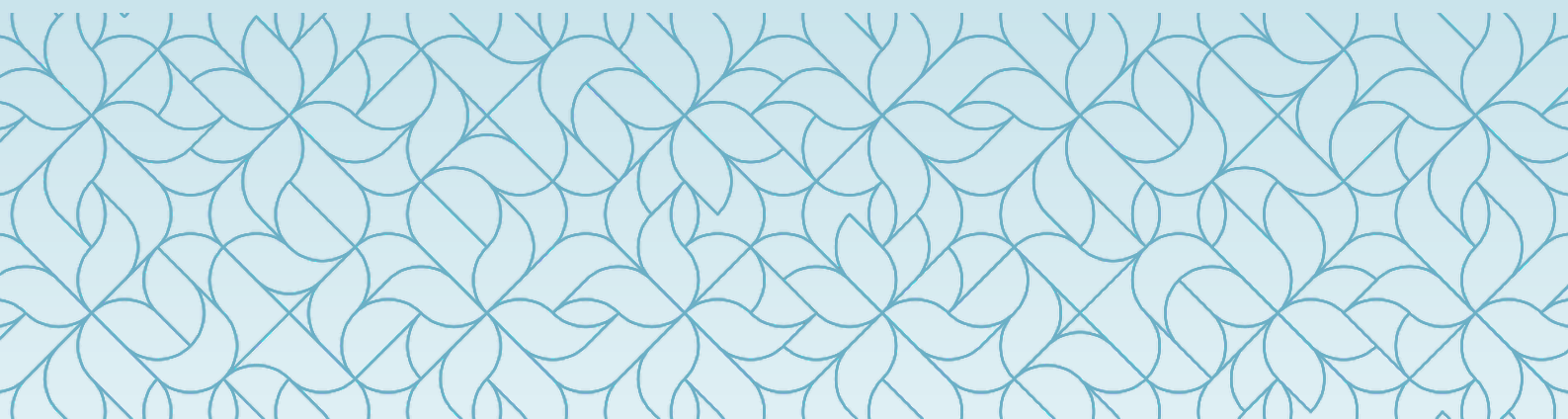
