# INTRODUCTION

The examination for this module is designed to test relevant candidates' knowledge and understanding on the rules and regulations under the Securities Markets Order, 2013 and its subsidiary regulations, notices and guidelines.

## WHO SHOULD ATTEND?

- A representative of a Capital Market Services Licence (CMSL) or an exempt person (a company who does not hold a CMSL but is licensed and regulated by Brunei Darussalam Central Bank (BDCB), who intends to apply for a Capital Market Services Representative's Licence (CMSRL) to conduct any regulated activity(ies) prescribed under Part II Schedule of Securities Markets Order, 2013.
- A person who is licensed as a CMSRL holder to conduct all regulated activities except for the safekeeping and administration of assets before to the implementation date of the Rules and Regulations Module.
- Any other person who does not fall within the aforementioned categories and wishes to take the examination are welcomed to register and take the examination.

## ASSESSMENT STRUCTURE

- The total self-study time required is 180 hours. Candidates are expected to complete the self-study 2 months prior to sitting for the examination.
